General Responsibility: The group with legal and fiscal responsibility that guides and oversees the carrying out of the functions described through the individual or group given operating responsibility.

Operating Responsibility: The individual or group that id directly responsible for carrying out or performing the functions consistent with the general guidance and oversight from the group holding general responsibility.

Must Approve or **Disapprove**: the group that must be involved in the decision-making process prior to the point of seeking approval. If I does not approve, a proposal cannot be adopted, of the proposed action taken until agreement is reached between the disagreeing groups. **Determined locally**: Management and functions as determined by the local governing body and in accordance with all Head Start regulations.
