## **Superintendent's Report:**

<u>AESD Executive Board – School Safety Presentation</u> – On September 18, 2018, Superintendent Lynch shared an update on school safety, ESSB 6032 and the \$722K Proviso with OSPI & ESDs, to the AESD Executive Board. He shared the series of slides and held discussion with the OESD Board today regarding school safety issues, the Regional School Safety Centers (RSSCs), legislation, and potential funding/apportionment/grant dollars.

As part of the legislative report, Kelly Schulz, 2015 graduate of Central Kitsap School District, was asked to share a little bit on lessons learned (Stanford student) worked this past year on a US Congressional Campaign. She also shared about her studies at Stanford and thanked the Board for their public service.

# **Legislative, State & Region Items of Interest**

- Our ESD, along with several others, will be participating in both Senate and House school safety work sessions; dates scheduled soon. The purpose is to discuss school safety needs. We are in dialogue with Senator Wellman (Chair EL & K-12 Ed) and Representative Dolan (V-Chair House Ed).
- We are planning our first Regional legislative engagement session tentatively on Oct. 26 or Dec. 7.
   Legislators, Board Members, Superintendents, Professional Organizations and the State Superintendent will be invited.

# **AESD Executive Board Report** – Carl Johnson

- Executive Board meeting was held on September 18, 2018. A presentation was provided on Federal Education Policy and bargaining update/overview from around the state. The general themes were shared about challenges with contracts and budgeting this past summer. Legislative Liaison Melissa Gombosky and AESD Executive Director Gene Sharrat also provided updates to the Group.
- The AESD website now includes a summary of the ESD story.
- At the WSSDA Conference in November, an ESD specific workshop will be offered.
- AESD Annual Conference will be held at Skamania Lodge draft program and keynote speaker information was presented to the Executive Board.
- OESD Board members discussed opportunities to meet with School District Board members: WSSDA Regional Meeting on October 27, and also during caucus, or for an informal breakfast meeting at the WSSDA Conference in Spokane.

# **Financial, Technology, and Human Resources – On behalf of** Monica Hunsaker, Sue Armstrong noted the following:

- **Budget Status:** The next Budget Status report will be presented in January.
- **Board Policy Revision Schedule:** A schedule of revisions was provided to the Board. A consultant has been hired to make the revisions (A former Human Resources Director at ESD 113 and also experienced with policy revisions for other ESDs).
- **OESD Salary Study:** A consultant has been hired to conduct a salary study this year. Local salaries for certificated and classified staff (post negotiations), are important considerations during the study.

School Employees Benefits Board (SEBB): The OESD is anticipating School Employees Benefits Board (SEBB) plans to be provided next year (2020) as required by the Washington State Legislature's decision made in 2017. ESDs are evaluating the anticipated fiscal impacts for school districts.

#### **Teaching and Learning Services -** Susan Jung Lathrop highlighted the following:

- Teaching and Learning Updates:
  - Safety Proviso: Working on a Kaiser-Permanente grant to explore feasibility of OESD becoming a licensed mental health provider. OESD also secured a Salish Behavioral Health Grant for a Student Assistance Prevention Coordinator position in Port Townsend. As part of the Safety Proviso work, the OESD is potentially looking to hire a consultant to assist with coordinating the services of the School Safety and Security Cooperative.
  - Exploring the possibility of opening a Deaf and Hard of Hearing preschool program for our region in partnership with North Mason School District. Washington State Center for Childhood Deafness and Hearing Loss would provide the teacher.
  - Climate Science grant: we continue to run professional learning with teachers and engage with our community partners. New ELA/MATH/SCIENCE fellows joined our network this year; Friday, September 21, is the kick-off.
  - Computer science grant: One meeting has been held with the ESDs; next step is to work with districts to identify how best to meet their needs with intent of the grant.
  - Results from the Early Learning Program Performance Summary Report (April 9-13, 2018) were shared.
- Head Start/Early Head Start/ECEAP/Coalition information presented below.
