### <u>L&I Update on WAC 296-65 Asbestos Removal</u> <u>and Encapsulation</u>

- 1. Affidavit documenting supervisor qualifications
- 2. Make worker certifications valid from class completion so graduates can get to work
- 3. Reduced project pre-notification period from 10 to 5 days
- 4. Clarify when certified asbestos supervisors are required (Asbestos abatement projects)

### <u>L&I Proposed Changes for WAC 296-307</u> Agriculture Part I Pesticides Worker Protection

- 1. Definition of immediate family
- 2. Cartridge change out schedule
- 3. Enclosed cab respirator
- 4. Use of most protective personal protective equipment
- 5. Eyewashes must provide 0.4 gallons or 1.5 liters per minute for 15 minutes with single point of operation
- 6. Heat stress requirements retained

They attended OSHA courses at UW on assessing and protections for confined spaces. As we all know classes can only get us so far though. Colleen reached out to L&I and connected with Jeff Spann who has been an excellent resource. Next school year there will be confined spaces courses provided by Jeff at

the OESD in Bremerton and the Lincoln Center in Port Angeles. There will be a course for Supervisors that will give an overview on how to assess a confined space and add a site specific section to your Accident Prevention Program. 

### **CONFINED SPACES**

### **Confined Spaces Regulations**

WAC 296-809 Safety Standards for Confined Spaces. There are two types of confined spaces: Permit-Required and Non-Permit Required. Section 200 explains the requirements to identify and control entry into permit required spaces.

### **Assessing Confined Spaces**

A confined space is all of the following:

- Large enough and arranged so an employee could fully enter the space and work.
- Has limited or restricted entry or exit.
   Examples of spaces with limited or restricted entry are tanks, vessels, silos, storage bins, hoppers, vaults, excavations, and pits.
- Not primarily designed for continuous human occupancy.

A permit required confined space has one or more of the following capable of causing death or serious physical harm:

- Has, or the potential to have, a hazardous atmosphere.
- Materials with the potential for engulfing someone who enters.
- Internal configuration that could allow someone entering to be trapped or asphyxiated by inwardly converging walls or by a floor, which slopes downward and tapers to a smaller cross section.
- Contains any physical hazard. This includes any recognized health or safety hazards including engulfment in solid or liquid material, electrical shock, or moving parts.

- Contains any other recognized serious safety or health hazard that could either:
  - Impair the ability to self-rescue.
  - Result in a situation that presents an immediate danger to life or health.

### **Confined Spaces Program**

A program should be included in your district APP as a site specific program under the department that manages the program, such as facilities/maintenance. The program will include the location of the space, the type (permit or non-permit), and the procedures for entry. The requirements for a permit required confined space entry program are listed under WAC 296-809-30002. Employees must be trained on the program and the spaces they are allowed to enter.

#### Where to Start
