After selecting the book for your Read Aloud, you will need to look up the book's publisher and reference the list below for requirements and permissions so that Bonnie can, legally, upload your Read Aloud Video to your YouTube Channel. This list is in alphabetical order.

August House

Permission for Recording and Posting Read-aloud Stories from August House

August House, Inc. is committed to sharing stories from the world's great oral traditions. During this challenging time of the Covid-19 pandemic, August House, Inc. is supporting classroom teachers, families, educators and librarians who wish to use our stories in a variety of ways. As a result, August House, Inc. grants permission to teachers, families, educators, after school care providers

and librarians who would like to record and post online read-aloud versions of our titles for educational and non-commercial purposes.

Please follow these basic guidelines:

- At the beginning of your recording, please note that you are reading/recording the book with permission from August House, Inc.
- Read-aloud recordings can be shared on any site or social media platform where there is

Support for Classroom Read-Aloud Videos and Read-Aloud Live Events

During these challenging times, Bloomsbury wishes to support parents, teachers and children while schools and public libraries are closed as a consequence of the COVID-19 pandemic.

Bloomsbury is therefore permitting teachers, authors, librarians and booksellers to create and share story time, read-aloud videos and live events temporarily, according to the below guidelines.

PLEASE NOTE:

- These permissions are granted only in respect of teachers and educators providing distance learning to students in a virtual classroom setting, and to authors, booksellers and librarians who wish to provide a live reading aloud experience to young people who would normally visit a library or bookshop in person.
- Permission is granted only for free use of the readings, and you may not charge in respect of any of the activities mentioned below without formal agreement from Bloomsbury.
- Bloomsbury grants the permissions set out below until December 31, 2020.

In every case where a Bloomsbury book is read out loud we request that the title of the book and the name of the author and/or illustrator are announced at the beginning of each read aloud video or live event.

For Teachers and Educators – Story Time or Read Aloud Videos

- Story time or classroom read-aloud videos in which a Bloomsbury book is read aloud (and, in the case of picture books, displayed) may be created and posted solely to closed educational platforms or to another closed network or platform where access is restricted to pupils of the teacher or educator.
- If a teacher or educator plans to share a story time video by recording a video, uploading it to a YouTube channel, and posting a link to that YouTube video inside a closed educational platform, that YouTube video must be designated as "Unlisted" (not "Public") when uploading.
- These story time and classroom read-aloud videos may be hosted on the educational or other closed platform and/or or YouTube (as an "Unlisted" file – see above) until the end of the current school year, after which they must be deleted from the relevant platform unless this permission is extended by formal agreement with Bloomsbury.

For Bookshops, Public Libraries and Bloomsbury Authors—Live Streaming:

Live events in which a Bloomsbury book is read out loud (and, in the case of picture books, displayed) may be streamed live, in real time, on social media platforms such as YouTube,

Facebook Live, Twitter, and Instagram. Because these platforms automatically archive live events, when your event has finished, please immediately delete the link associated with the event and the recording of the event from your account.

Please note that many Candlewick Press books are available in audio and/or video formats. You may wish to seek out those versions of the books to meet your needs instead of making your own.

Live Readings:

Live readings of Candlewick Press books that are not recorded do not require permission from Candlewick Press. Librarians, teachers, parents, caregivers, members of the clergy, and staff of museums, bookstores, and nonprofits can, through virtual means, read any Candlewick Press title live to their patrons, students, and children. However, these readings cannot be archived or saved. Videos should not be live streamed to any social media, but should instead be hosted on a private server or closed educational platform, with limited access for students, patrons, or customers.

Reading live via Zoom in a closed setting such as a classroom or bookclub is permitted. If you do not have access to a closed platform, then you may post the video to YouTube provided the video is non-public, with the setting as "private" or "unlisted." Instructions on how to do so can be found here.

For Teachers and Educators providing distance learning to students in a virtual classroom setting:

Story time or classroom read-aloud videos in which a Penguin Random House book is read aloud and the book is displayed (for picture books) may be created and posted to closed educational platforms such as Google Classroom, Schoology, Edmodo and Discovery Education, in order to replicate the read-aloud book experience that would otherwise be available to educators in the classroom.

If a Teacher or Educator plans to share a story time video by recording a video, uploading it to a YouTube channel, and posting a link to that YouTube video inside a closed educational platform, that YouTube video must be designated as "Unlisted" (not "Public") when uploading. These story time and classroom read-aloud videos may be hosted on the educational platform and/or YouTube (as an "Unlisted" file) until the end of the current school year, after which we request that they be removed from the educational platform and/or from YouTube, unless this permission is extended for the next school semester.

As an Open License, permission will be deemed granted upon submission of the required information on the form, and your compliance with the above guidelines. However, we recognize this may not be possible, in which case you may post your video on YouTube, provided the video is posted as "unlisted" (not public) and you only share a link to the video with your students. Click here for instructions on how to upload a video to YouTube as unlisted.
- 2. At the beginning of your video, please state that you are presenting your reading "with permission from Scholastic."
- 3. Please delete your video or disable access by the end of this current school semester, but no later than December 31, 2020, unless we announce an extension to this policy.
- 4. Please complete the Permission Form available here.

By posting a reading, you are agreeing to abide by the above terms.

Live streams cannot be available to the public or recorded or permanently archived on any social media platforms. Live streams may be available for a 24-hour period after their initial recording. After the 24-hour period has ended, all efforts must be made to ensure that all potential recordings and archives are deleted.

Reading and Reporting guidelines must be followed for all video posts and live streams.

Librarians and Booksellers

Librarians and Booksellers may include Sourcebooks titles in live reading events on YouTube, Facebook Live, Instagram Live, Twitter, or other live streaming platforms provided that said live events are not recorded or posted.

Live streaming events that include Sourcebooks titles cannot be recorded or permanently archived on any social media platforms. Live streams may be available for a 24-hour period after their initial recording. Please keep in mind that most social media platforms automatically archive live streams.
